

SUMMARY ANNUAL REPORT FOR BLUE DIAMOND GROWERS WELFARE BENEFITS PLAN

This is a summary of the annual report of the BLUE DIAMOND GROWERS WELFARE BENEFITS PLAN, a health, life insurance, dental, vision, prepaid legal, long-term disability and death benefits plan (Employer Identification Number 94-0355780, Plan Number 501), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BLUE DIAMOND GROWERS has committed itself to pay certain Health claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Kaiser Foundation Health Plan Inc, Provident Life and Accident Insurance Company, Pre-Paid Legal Services, Inc dba LegalShield, Vision Service Plan, Unum Life Insurance Company of America, Sutter Health Plan, Companion Life of California and Delta Dental of California to pay certain Health, HMO contract, ACCIDENT, CRITILLNESS, ISWL STND, WHOLE LIFE, Legal Services Plan Memberships, Vision, Life insurance, Long-term disability, AD&D, Lifestyle Life, Prescription drug, Stop loss, Dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$15,798,747.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$906,377 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$2,116,830.
